Open Public Forum

- Barrie Spencer raised the issue of an open letter from NALC ref trying to lower age profile
 of councillors. It was agreed to look at promoting the campaign where the Parish Council
 could. Cllrs Spencer and Tamsett-White agreed to help with printing where possible
- Site Inspection Pinewood Drive.

Some parishioners were unhappy about exchanges that took place at the site meeting, and more importantly that there was no official Parish council representation at the South Hams Planning meeting. There was a prolonged discussion, also including reference to the Neighbourhood Plan. Apologies were offered to the wider community in respect of the lack of attendance by Cllr Tamsett-White and Cllr Spencer. Cllr Blake also apologised in respect of the same and that he had not contacted every councillor to see if they might have been available at the SHDC Planning meeting.
