Minutes of the Meeting of Bickleigh Parish Council which was held on Thursday 24th February at 7.30pm in the Woolwell Centre.

Open Forum

3 Members of the public were in attendance

Woolwell in Bloom requested support from BPC to get a definitive answer for permission to create the Jubilee garden. **Clerk to chase.**

Opportunities for grant funding towards the project were discussed **and CS to send info. to Woolwell in Bloom.**

The meeting convened.

2022 16 Apologies were received from Cllr Paul Blight and Cllr Barrie Spencer (SHDC)

It was noted with regret that Clirs Rundell and Rhodes had both tendered their resignations. **CS** thanked both of them on behalf of the Council for their work for Bickleigh Parish.

2022 17 Personal or pecuniary interests in items on the agenda and the nature of that interest.

Councillors Spencer and Haymes declared a pecuniary interest as employees of the Woolwell Centre.

2022 20 To raise any matters arising from the minutes of the last meeting.

- Correspondence from a resident concerning the Leat Walk trees was discussed. **Clerk to reply to the resident.**
- CS reported that further to the decision at the last meeting to purchase solar powered lights for the path to the scout hut in Woolwell, the scouts had now agreed to fund the annual electric charges and so the original purchase would continue.
- LTW to review methods of road cleaning with Arbocure

2022 21 Finance

- c) The 3 expressions of interest from internal auditors were considered and it was agreed to work with Alison Marshal for the 2021-2022 audit.

2022 22 Devon County Council Grass cutting contract

Receipt of the DCC urban grass cutting agreement for 22/23, the 3% inflation and charge of £4,707 were noted and the **clerk was delegated authority to sign the contract**.

2022 23 Woolwell Centre

- b) The matter of seeking professional advice over the works at the Woolwell Centre to ensure compliance with regulatory and statutory requirements using the DCC joint venture company was delegated to The Woolwell Working Group to consider and make a recommendation for the March Council meeting. LT to call the meeting.
- c) It was agreed that the clerk would contact Plymouth City Council regarding the condition of the lane into the Centre car park
